The project continued in WA with the establishment of Healing and Support groups and counselling for members of the Stolen Generations and their families. Training workshops were also conducted for Aboriginal Mental Health workers at Marr Mooditj and the Aboriginal Psychiatric Services.

Another major activity was providing support to the WA Stolen Generations Working Group established to represent the interests of the Stolen Generations in WA in relation to State and Commonwealth funding made available in response to the recommendations of the "Bringing Them Home" report. This group is currently in the process of becoming incorporated.
